1) Background

Mt Elgon Agroforestry Communities Cooperative Enterprise Limited (MEACCE) intends to develop a Warehouses, Office space, and milling/ hulling plant on its land in Mbale Plot 940, Bugwere Road, Industrial Park. The Project will be executed in 3 phases, as follows;

- Phase 1: Land leveling, drainage, perimeter fencing, and utility connections (Water & electricity).
- Phase 2: Storage/ warehouses and processing plant.
- Phase 3: Administrative Offices

MEACCE invites qualified Architectural firms to submit applications for master planning and full design services aligned with the intended plan.

2) Scope of Services

The selected firm will be expected to deliver comprehensive Architectural services, including;

- Site reconnaissance, topographic survey coordination, soils and geotechnical investigations;
- Risk and constraints analysis, including environmental and regulatory considerations.
- Conceptual master planning and phased development plan with block footprints, circulation plans, utilities corridors, storm water drainage, parking and allowance for future expansion.
- Schematic design and detailed architectural drawings for:
 - ✓ Phase 1 civil works;
 - ✓ Phase 2 buildings (warehouses, and processing plant).
